

The National Research Foundation of Ukraine (NRFU)

Is a state budgetary non-profit organization the main purpose of which is grant support for fundamental research in natural, technical, social and humanitarian sciences, as well as applied research and scientific and technical (experimental) developments in priority areas of science and technology.

The **NRFU** was established by the Cabinet of Ministers of Ukraine and reports directly to it.





In the first years of its existence the main vector of the Foundation's activities was directed at

- providing grant support to young scientists because such support is a modern form of encouraging young people to carry out scientific research using capacities of the world's leading scientific institutions;
- upgrading scientific equipment and facilities that have received limited support from the state over the past 20 years;
- directing scientific efforts to research related to biosafety (COVID-19), biomedicine, ecology, cyber and information security;
- monitoring of the most powerful scientific developments and inventions.



The main objectives

- stimulation of national fundamental and applied scientific research;
- development of research infrastructure in Ukraine and its international integration;
- development of infrastructure of scientific research;
- young scientists' research project support;
- popularization of science.

Stages of competitive selection of scientific and research projects:

Call proposals Submission of Formation and preliminary Call for proposal call proposals approval of the evaluation (by and other list of experts formal criteria) documents Formation of Concluding Call results Call proposals rating lists of agreements with approval assessment by call proposals the winners experts



Transparent selection procedures

In order to ensure efficient and rational use of budgetary funds, the Foundation introduces transparent procedures for competitive project selection which minimize the impact of the human factor on allocation of financial resources, giving a considerable part of the selection functions to automated algorithms of the NRFU digital information system.





Independent assessment of call proposals

Assessment of call proposals is done by independent experts in respective fields of science and technology.

Scientific and technical assessment of each project is carried out by at least three experts, usually including one foreign expert.

We ask researchers worldwide to communicate to their governments and to demand from them:

- truly devastating sanctions against the RF;
- provision of modern **weapons** to Ukraine;
- introducing a **No-Fly Zone** over Ukraine;
- embargo on the import of Russian energy commodities

"Address to Russian Scientists"

The NRFU sent 49,000 letters to Russian research institutes, research centers, universities as well as many academics and corresponding members of the Russian Academy of Sciences with a reminder of what honor of scientists is and an appeal to speak out against Russia's criminal aggression against Ukraine, war crimes and genocide of the Ukrainian people.

Most of the answers were obscene, full of imperial malice and chauvinism. It would be naive to expect that in Putin's Reich, after 22 years of total nazification, a significant number of scholars remember the basic principles of human morality.

We received only a few answers from true scholars. In their letters, they express indignation at the Russian aggression and admiration for the heroic struggle of the Ukrainian people. One such letter reads:





The grant season 2022 was suspended until the final victory over the russian occupiers

According to the **Resolution of the Cabinet of Ministers of Ukraine** of March 10, 2022 No. 245,

funds in the amount of £25 MLN (£790,613.9 mln) that were envisaged to ensure the activities of the Foundation, as well as grant support for research and scientific and technical (experimental) developments in 2022, were directed to ensure the needs of the Armed Forces of Ukraine to combat the full-scale military invasion.
